

EXHIBIT "C"

CONDO UNIT OWNER SIGN CRITERIA

GENERAL:

The installation of a sign and costs incurred shall be the responsibility of the Condo Unit Owner, including damage to common elements as a result of such signage. Sign construction is to be completed in compliance with the instructions, limitations and criteria contained in this Exhibit:

- 1. The objective of the sign criteria is to provide a uniform, professional and consistent sign format among SCCA Condo Unit Owners.
- 2. Sign drawings/renderings shall be submitted to the SCCA Board of Directors for written approval. Sign drawing shall clearly show graphic as well as construction and attachment details. Full information regarding electrical requirements and brightness is to also be included, if illuminated.
- 3. All signs shall be designed to meet local sign ordinances and must be installed by a contractor who is registered with Brevard County if a sign permit is required.
- 4. The wording of signs shall be limited to Condo Unit Owner's (or Tenant's) Trade Name only.
- 5. Condo Unit Owner (or tenant) will be permitted one sign only to be located above the storefront/entryway. End units may also have one additional sign on the side of the unit as well.
- 6. Sign specifications:
 - a) Black letters; no other colors
 - b) Block style, not cursive
 - c) Plastic lettering material
 - d) Font style and sizing consistent with existing signage on other SSCA units
- 7. Sign shall be mounted on the exterior wall fascia surfaces immediately in front of Condo Unit Owner's Unit area and/or side exterior wall fascia for end units.

- 8. No part of such sign shall be closer than 18" to the side lease lines of the Unit nor closer than 18" to the top and bottom of the Condo Unit Owner's sign area between trim elements. No part of the sign shall hang free of Condo Unit Owner's sign area. Sign may be on curved or flat portion of the exterior wall, but not bridge both.
- 9. Signs must be installed within 90 days of move-in.
- 10. Window and door signage will be considered upon prior written consent of the SCCA Board of Directors.
- 11. Street-front marquis signs must fit within allotted spaces, but may contain colors and graphics as desired on a single sheet, translucent plastic panel.
- 12. No other signs shall be permitted such as, but not limited to, parking lot signs, pavement painted signs, signs on poles or posts, or temporary "wire rod and corrugated plastic sheet type" signs.
- 13. At the sole discretion of the SCCA Board of Directors through a consensus vote, the Condo Unit Owner may be granted the right to deviate from the above referenced signage standards.
