ARTICLES OF INCORPORATION

OF

The undersigned incorporators to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under Chapter 617, Florida Statutes.

<u>ARTICLE I. NAME</u>

The name of this corporation is A DAY IN THE SON, INC.

ARTICLE II. GENERAL PURPOSE

The purpose for which this corporation is organized shall be to carry on the business of Christian public ministry events, including but not limited to sponsoring, organizing, administering, enhancing, and operating music, entertainment, art and cultural exhibitions, assemblies and activities that benefit the public through the public exhibition and display of such works and other objects of cultural significance, and to engage in any lawful purpose or purposes not for pecuniary profit. The purpose for which this corporation is organized is exclusively for religious, charitable, and educational activities as is defined under the Internal Revenue Code, Section 501(c)(3); to do all such things as is lawful to further such purposes. No part of the net earnings of this corporation shall inure to the benefit of any private member or individual. No substantial part of the activities of this corporation is for the purpose of propagandizing or otherwise attempting to influence legislation and this corporation shall not participate or intervene in a political campaign on behalf of a candidate for public office. Upon dissolution, the assets of this corporation will not be distributed to its members or shareholder.

ARTICLE III. COMPLIANCE WITH SECTION 501 (C) (3). INTERNAL REVENUE CODE

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue code

of 1986, or corresponding Section of any future Federal Tax Code, or shall be distributed to the Federal, State, or Local government for a public purpose. Any such asset not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located exclusively for such purposes.

ARTICLE IV. MEMBERS

No Members. The corporation shall not have members and shall not issue membership certificates. The corporation shall not issue shares of stock.

ARTICLE V. DURATION

This corporation shall have perpetual existence commencing on the date of filing of Articles of Incorporation by the Department of State.
