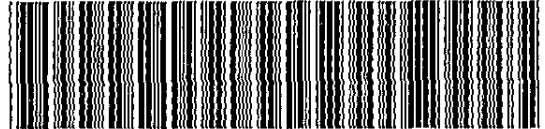

ARTICLES OF INCORPORATION
NOVEMBER 28, 2005

- A Non-profit Corporation -

ARTICLE I
NAME

The name of the corporation is Hyde Park Preservation Foundation, Incorporated

ARTICLE II
PRINCIPLE OFFICE

The principal office and mailing address of the corporation is 223 Triplett Road,
Crawfordville, FL 32327.

ARTICLE III
PURPOSES

SECTION I

In general, the organization is organized to support the social welfare of the community. The purposes shall include, but not be limited to the following:

- To collect, evaluate and display artifacts, documents and memorabilia particularly of Florida and the local community;
- To raise awareness of the need for preservation and the increase understanding of the contributions diverse populations, especially African Americans, made to this country;
- To promote scholarships and invest in education;
- To bring visibility to and to address social needs in an effort to achieve sustainable and "healthy" communities; and
- To support, enhance and/or develop economic development initiatives in the community.

SECTION II

All the assets and earnings of the corporation shall be used exclusively for the exempt purposes set forth above, including the payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no substantial part of its activities shall be for the carrying out of a program of propaganda or otherwise attempting to influence legislation. The corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income taxation under Section 501 C (3) of the Internal Revenue Code of 1954 (or corresponding provisions of any subsequent revenue laws). The corporation shall have no capital stock, pay no dividends, distribute no part of the income to its members, directors, or officers, and the private property of the subscribers, members, directors, and officers shall not be liable for the debts of the corporation.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

SECTION I INITIAL BOARD OF DIRECTORS

A Board of Directors, each of whom shall be members of the corporation, shall govern the corporation. The initial board shall be volunteers according to their areas of expertise and shall be ratified by members of the organization through an oral vote. Subsequent elections shall be by a majority vote of the board by ballot as specified in the bylaws. There shall be five (5) directors on the initial Board. The number of directors may be increased or decreased, but shall never be less than three (3) and more than eleven (11).

ARTICLE V INITIAL REGISTERED AGENT/INCORPORATOR AND STREET ADDRESSES

In accordance with Section 617.0501 and 607.0505 Florida Statutes, Bossie Hawkins is hereby designated as the Registered Agent. His address is 1410 Lola Drive, Tallahassee, FL 32301.

The name of the Incorporator is Rosa T. Brown. Her address is 2825 W. Orange Avenue, Tallahassee, FL 32310

ARTICLE VI INITIAL BOARD OF DIRECTORS

The names of the persons who are to serve as the initial directors of the corporation and who shall be subject to all the provisions of the purpose relating to the directors are as follows:

ARTICLE VI LIMITATION OF CORPORATE POWERS

Said organization is created exclusively for charitable, religious, educational and scientific purposes, including for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII TERM OF EXISTENCE

The corporation shall have perpetual existence. Corporate existence shall commence on the date of the filing of these Articles of Incorporation with the Florida Division of Corporations.

ARTICLE IX - DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code for a public purpose.

Having been named as Registered Agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as Registered Agent and agree to act in this capacity.
