## SHARNELL JACKSON MINISTRIES, INC. A Non-Profit Corporation

A Non-Profit Corporation

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

First: The name of the Corporation shall be Sharnell Jackson Ministries, Inc.

**Second**: The place in this state where the principal office of the Corporation is to be located at 4158 Inverrary Dr #505, Lauderhill, FL 33319, in the City of Lauderhill, Broward County.

**Third**: Said corporation is organized exclusively for charitable, religious, and educational, purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
