

# **ARTICLE I-NAME:**

Alfonza Tate, Inc. This Corporation is organized pursuant of the Florida Non-profit Corporation Code.

# ARTICLE II OFFICE:

The principle office for the corporation shall be 3141 N.W. 134 Street, Opa Locka 33054

# **ARTICLE HI-SERVICE AREAS:**

Services shall be provided to clients residing in the Opa Locka/ North Dade communities of zip codes 33054, 33055.

# **ARTILCE IV - MISSION:**

This Corporation is not organized for the private gain of any person of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law, for charitable and educational purposed to aid small businesses, elderly, poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Seminars, Outreach Advocacy programs for the Literacy, Counseling, Temporary Shelter, Teen Pregnancy, Job Training, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care. We will also provide other innovative support services and programs to those living in these communities that are considered most in need.

# **ARTICLE V-MEMBERS**

#### 1. Eligibility

- a. All members of Alfonza Tate Inc. Corporation shall be 18 years an older to represent a cross section of those services provided.
- b. Members may be appointed for life experiences or professionalism Regardless of residence.

#### 2. Responsibilities:

- a. Members of the corporation shall meet annually to elect directors to Serve on the Board of Directors and to consider amendments to the By-Laws.
- b. Members of the Board of Directors shall meet monthly of the Monday after the first Sunday.
- 3. Notice of meetings of Board of Directors;

Written notices of each meeting shall be given out less that five (5)
Days before meeting is to be held, specifying the place, day and hour
Of the meeting. Notice may be given by mail, handbill, and church
Bulletin, new publication or such additional means as the Board of
Directors shall determine.

#### 4. Annual Meetings.

The annual meeting of the corporation shall be held in December of Each year. The purpose of the annual meeting is to elect directors And to consider amendments to the By Laws, if any have been Adopted by the Board of Directors.

### 5. Special Meetings:

The Board of Directors may call special meeting of a member Or by written petition of at least 30% of the membership, at lease

five

Days in advance to the meeting date.

#### 6. Voting.

Each member shall have one vote; all matters shall be decided by a Majority of the members present.

#### ARTICLE VI -Board of Directors (Board)

1. The Board of Directors shall consist of no less than four and no more than twelve.

- 2. The Board shall be responsible for the business of the corporation including legal, policy making, financial and program planning.
- 3. The Board shall be composed of eight elected and four appointed.
- 4. The terms of office shall be: elected for three years and appointed for one year, each position shall be elected for no more that three terms (nine (9) years.
- 5. Officers of the Board of Directors;
  - a. Chairman / Chairperson

    The chairman shall perform all duties as prescribed the ByLaws and shall preside at all Board meetings according to
    Roberts Rules of Order.
  - b. Vice Chairman shall act in place of the chairman in the absence Or refusal of the chairman to preside.
  - c. Secretary.
    - (a) The secretary shall keep the minutes of all meetings and will be the custodial of records. Other duties include filing of the annual corporation's paper and all duties incident to the office of the secretary.
    - (b) Sign with the chairman, executive director and other officers on capital certificates and corporation papers.
  - d. Treasure
    - (a) The treasurer shall provide a monthly financial Statement to the board.
  - (b) Submit a full financial report at the annual member meeting.
    - © Compile all financial records for annual audit.
    - (d) Reconcile all monthly financial statements
    - (e) Write all checks and pay bills approved by the Board

#### Article VII Removal from office

- 1. Members may voluntarily resign at anytime
- 2. Members are removed if term has expired.
- 3. Members are removed if not re-elected
- 4. Members may be terminated by 2/3's vote of Board of Directors for cause, unprofessional conduct or more than three months unexcused absence.

#### Article IX-Compensation

- The Board of Directors and officers shall not receive Directly or indirectly any salary, compensation or gifts (Except nominal gifts) from the corporation. Approval trips for Board business may be allowed if funds are available.
- 2.Indemnification of directors and officers. Members of the

Board of Directors shall not be held liable for actions of the Board unless negligence or misconduct occurs.

## Article X Checks

Checks shall be signed by at least two parties of the approved Check signers chairman, vice chairman secretary and Treasurer. All checks must be prior approved as a budgeted Item or by resolution.

## Article XL - By-Laws

- 1. These By-Laws may be amended, altered or repealed by Resolution adopted at any regular of special meeting of the Board of Directors, provided notice of such meeting specifies the intent to amend or repeal these By-Laws, and by a 2/3's vote of the Board of Directors.
- 2. The amendments alterations or repeals shall be presented at the Next annual meeting for approval or disapproval.

## ARTICLE FOUR

## DIRECTORS

The Board of Directors shall manage the business affairs of this corporation. The number of Directors shall not be less than 4. The number of Directors may e increased or decreased from time to time as prescribed by the by -laws.
