ARTICLE I: NAME

The name of the corporation is: GOSPEL MISSION FOR CHRIST MINISTRIES, INC.

ARTICLE II: PURPOSE FOR WHICH ORGANIZED

The purpose for which the corporation is organized is:

A. *To engage in any nonprofit activity permitted under the laws of the United States and of the State of Florida, and particularly for the operation on a nonprofit basis of an adult group home for the mentally and physically challenged.*

ARTICLE III: INCORPORATORS


