PREAMBLE

WE BELIEVE:

That God's purpose concerning man finds fulfillment in a priority reasonfor-being: (1) to be a corporate body in which man may worship God, (2) to be vessels of God's purpose to build a body of believers conformed to the image of His Son, (3) to be ambassadors of God to evangelize the world.

That Overcomer Ministries, Inc. exits for the purpose of giving continuing emphasis to these purposes established in the New Testament by the apostolic pattern by teaching and encouraging believers to be baptized in the Holy Spirit giving them power to evangelize with signs following and enabling them to respond to the full working of the Holy Spirit in expression of fruit and gifts and ministries as in New Testament times for the edifing of the body of Christ and expressing heart felt worship to God.

Therefore, we recognize ourselves as a body of Christian believers according to the spiritual plan for the local assembly, in order that we may worship God as a united body, exercising all our inalienable rights and privileges granted to a religious body by the Constitution of the United States of A merica and the Constitution of the State of Florida and do hereby adopt the Articles of Incorporation and these by-laws and do agree to be governed by them.

ARTICLE I. NAME

The name of this Corporation/Congregation is Overcomer Ministries,Inc., which is located in Gainesville, Florida, a non-profit organization incorporated under the appropriate laws of Florida.

<u>ARTICLE II. TERRITORY</u>

It shall include the work of the Overcomer Ministries, Inc., which is located in Gainesville, Fl, and surrounding areas with mailing address: 9938 SW Archer Road, Gainesville, FL 32608.

ARTICLE III.PREROGATIVES

<u>SECTION 1.</u> This body shall encourage and promote the worship of God, the edification of believers and evangelization of the world.

<u>SECTION 2.</u> This church shall have the right to govern itself according to the standards of the Holy Bible "Endeavoring to keep the unity of the spirit in the bond of peace till we all come to the unity of the faith and the knowledge of the Son of God, to a perfect man, to the measure of the stature of the fullness of Christ" (Eph. 4:3, 13).

<u>SECTION 3.</u> This church shall have the right to purchase or acquire by gift, bequest, or otherwise, either directly, or as trustee, and to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose of any real estate or chattels as may be desired for the furtherance of its purposes; all in accordance with its constitution and by-laws or as the same may be hereafter modified or amended.

<u>SECTION 4.</u> This church shall have the right to establish, develop, and maintain any and all ministries it may deem appropriate to the fulfilling of its reason for being. This includes, but shall not be limited to:

- 1. A training and educational program for members.
- 2. Pre-school care and education for children and youth.
- 3. The duplication and distribution of audio and video tapes.
- 4. Cell extention groups.
- 5. Healing and care teams.

<u>SECTION 5</u>. Neither race, color, nationality or ethnic origin shall be a consideration in a person's right to be a member of, or participate in all the rights, privileges, programs, activities and ministries of Overcomer Ministries, Inc.

ARTICLE IV. MANNER OF ELECTION

The President of the corporation (which is the Pastor) will appoint the Vice-President, Secretary, and Treasurer, which are the Board of Directors. They will be confirmed by a vote of confidence by the members. In the event of vacancy of the Senior Pastor, the Board of Directors will appoint a Pastor.
