

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

THE VILLAGE AT TOWN CENTER CONDOMINIUM ASSOCIATION, INC.

WHEREAS, the Articles of Incorporation of The Village at Town Center Condominium Association, Inc., a Florida not-for-profit corporation (the "Association"), were filed with the Florida Department of State on December 2, 2005 as Document Number N05000012141 and were recorded as an Exhibit to that certain Declaration of The Village At Town Center, A Condominium (the "Declaration"), recorded December 9, 2005 in Official Records Book 6531, Pages 1093-1258, of the Public Records of Polk County, Florida (the "Original Articles");

WHEREAS, capitalized terms which are used but not defined herein shall have the meaning ascribed to them in the Declaration, as amended or supplemented from time to time, or the Original Articles;

WHEREAS, the Original Articles may be amended in accordance with the Original Articles, Chapter 617 of the Florida Statutes and Chapter 718 of the Florida Statutes;

WHEREAS, the Association desires to amend the Original Articles and the Declaration as set forth herein; and

WHEREAS, there are no members entitled to vote on the Articles of Amendment, and the amendment was adopted by the Board of Directors on August 31, 2016 (the "Effective Date").

NOW THEREFORE BE IT RESOLVED, in accordance with the foregoing, the Association hereby amends the Original Articles and hereby files these Articles of Amendment to the Articles of Incorporation of the Association. Article 3 of the Original Articles is hereby amended to read as follows (additions are double-underlined, and deletions are stricken through):

"<u>ARTICLE 3</u> PURPOSE

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act as amended from time to time through the date of these Articles of Amendment it exists on the date hereof (the "Act") for the operation of that certain condominium located in Polk County, Florida, and known as THE VILLAGE AT TOWN CENTER, A CONDOMINIUM (the "Condominium")."

FURTHER RESOLVED, except as specifically modified by these Articles of Amendment, the Original Articles and the Declaration remain in full force and effect.


