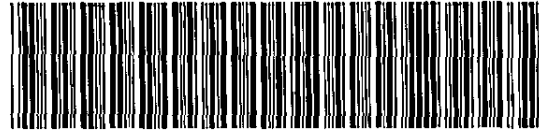

ARTICLES OF INCORPORATION  
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I  
NAME OF THE CORPORATION

The name of this corporation shall be Isaiah 58 of Indian River County, Inc.

ARTICLE II  
ADDRESS OF PRINCIPAL OFFICE

ARTICLE III  
EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV  
GENERAL NATURE OF BUSINESS

Isaiah 58 of Indian River County, Inc. is a Christ-centered ministry whose purpose is to help newly released prisoners begin to be assimilated into society. The organization will assist in areas to include, but not be limited to providing bus tickets, clothing, finding shelter, emotional support and other areas of initial support services.

The purposes for which Isaiah 58 of Indian River County, Inc. is organized are exclusively religious, charitable, and educational within the meaning of section 501 (c) (3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The powers of Isaiah 58 of Indian River County, Inc. are limited to those within the scope of section 501 (c)(3) of the internal revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, Isaiah 58 of Indian River County, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V  
DIRECTORS
