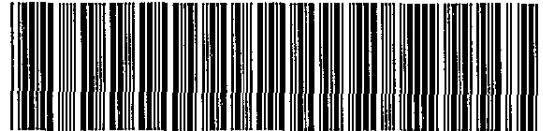



I, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, Chapter 617.

ARTICLE I
Name

The name of the corporation shall be **GAINESVILLE COMMUNITY RADIO, INC.**

ARTICLE II
Nature of Business

The purpose of this corporation shall be to encourage, promote and provide access to radio broadcasts to persons or organizations whose purpose is to educate and inform the public of matters of interest by making available low power radio transmissions.
