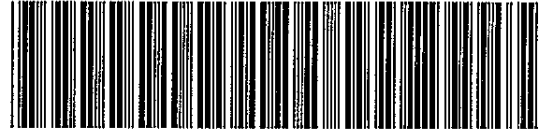

The undersigned incorporator to these articles of incorporation hereby forms a Corporation not for profit under the laws of the State of Florida as follows:

ARTICLE I

Name

The name of the Corporation is: Mount Olive Community Development Corporation.

ARTICLE II

Term of Existence

The date when corporate existence shall commence shall be the date of the filing of These articles of incorporation by the office of the Florida Department of State and the Mount Olive Community Development Corporation shall be perpetual thereafter.

ARTICLE III

Purpose

The Mount Olive Community Development Corporation is organized and shall be operated exclusively to encourage, support and assist the development and the redevelopment of social, economical, cultural, human services, historical restoration, ethnic programs and activities in Clearwater and surrounding areas of Pinellas County Florida.

The Mount Olive Community Development Corporation shall have all powers now and hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or require to carry out its purposes. All if the assets or earnings shall be used exclusively for the purposes hereinabove set out, including the payment of expenses incidental thereto. No Part of the earnings shall insure the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

ARTICLE IV

Members

The qualifications of members and the manner of admission of members shall be as specified in the bylaws of Mount Olive Community Development Corporation.

ARTICLE V

Initial Registered Office and Agent

The street address of the initial registered office of the Mount Olive Community Development Corporation is 600 Jones St. Clearwater, Florida 33755 and the name of its initial registered agent at such address is Ronald E. Williams Sr. the principal place of business is the same as the registered office.

ARTICLE VI

Directors

The Mount Olive Community Development Corporation shall have eight directors initially. The

numbers of directors may be increased or decreased from time to time as specified in the bylaws of the Mount Olive Community Development Corporation, provided that the Mount Olive Community Development Corporation shall always have at least three directors, and provided further that the initial directors may appoint not more than five additional directors before the bylaws are adopted. Dissolution

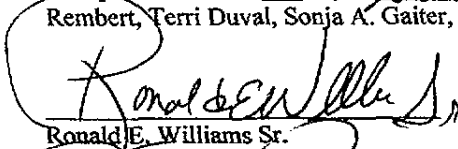
