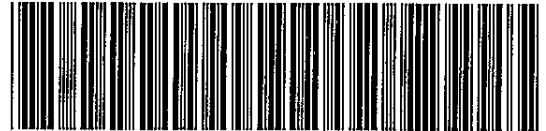

ARTICLES OF INCORPORATION OF

A nonprofit Corporation

We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

Name of Corporation

The name of the corporation shall be REFUGE LIFE CHANGING MINISTRY, INC.

ARTICLE II

Corporate Purpose

The object and purpose of the corporation shall be to establish and maintain churches, to establish and maintain schools for religious instruction and education, to establish and maintain daycare centers, to help the needy, and to do any other activities or business permitted under the laws of the United States and the State of Florida. All of the above-described corporate purpose shall be exclusively for charitable, religious, or educational purposes.

ARTICLE III

Capital Stock

No stock shall be issued for this corporation, which is a nonprofit corporation.

ARTICLE IV

Term of Existence

This corporation is to exist perpetually.

ARTICLE V

Principal Place of Business

The initial street address in this state of the principal office of this corporation is 217 S.W. 27th Avenue, Ft. Lauderdale, Broward County, FL 33312. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE VI

Membership

Section 1: Eligibility. Any person shall be eligible for membership in this Corporation upon application to and approval as provided in the Bylaws of this Corporation.

Section 2: Application for Membership. Any applicant meeting the qualifications set forth above and desiring to become a member of the Corporation shall make application on a form supplied by the Corporation and accompanied by such membership fees and dues as the Board of Directors may from time to time determine.

Section 3: Termination of Membership. Membership may be terminated by expulsion for a just cause or by resignation with thirty days prior written notice to the Board of Directors.

ARTICLE VII

Management

Section 1. The affairs of the Corporation shall be managed by a Board of Directors. The Board of Directors shall consist of not less than three (3) Directors initially. Directors shall be elected or removed in accordance with the procedure provided in the Bylaws.

Section 2. The Officers of the Corporation shall be a President, one or more Vice Presidents, a Secretary and a Treasurer. These officers shall be elected and shall hold office in the manner provided in by the Bylaws of the Corporation.

ARTICLE VIII
