That we, the undersigned residents of the State of Florida, have voluntarily associated ourselves together for the purpose of forming a non-profit corporation under and by virtue of the laws of the State of Florida.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in , or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 502(c) (3) of the Internal tax code, or (b) by an organization, contribution to which are deductible under

section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

(c) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501  $\bigcirc$  (3) of the internal revenue code. Or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
