# ARTICLES OF INCOPORATION OF PALM LAKES AT DELRAY BEACH CONDOMINIUM ASSOCIATION, INC. A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt the following articles of incorporation.

#### ARTICLE I: NAME

The name of this corporation is PALM LAKES AT DELRAY BEACH CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "association," these articles of incorporation as the "articles," and the bylaws of the association as the "bylaws."

#### ARTICLE IL PURPOSE

This association is organized for the purpose of providing an entity under the Florida Condominium Act ("the Act") for the operation of a condominium located in Palm Beach County, Florida and known as: Palm Lakes at Delray Beach Condominium, created under the declaration of condominium ("the declaration").


