b.No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members,officers or other private persons,except that the organization shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payment and distributions in furtherance of the purposes set forth in the purpose clause here of.At no time will this organization shall be the carrier off propaganda or attempt to influence legislation,nor will will it intervene, publish, distribute statementson behalf of any political campaign on behalf of any canidate for public office notwithstanding any other provision in this document,we will not carry on any other activities not permitted by an organization exempt from fedeeral income tax under sec. 501(c) (3) of Internal Rev. Code,

ARTICLE III

b. or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue code, or corresponding section of any government, or to a state or local government, for a public purpose. Assets not disposed of shall be disposed by the court of common Pleas of the county where the main organization is located, exclusively for the purposes or to such organization or organizations, the court will determine which is organized for such purposes.
