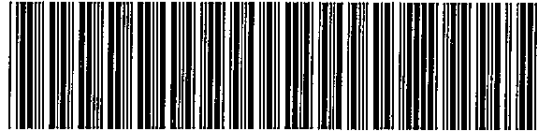

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **LEJEUNE SEGOVIA NEIGHBORHOOD ASSOCIATION, INC**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **424 Almeria Ave., Coral Gables, FL 33134.**

ARTICLE III: PURPOSE

The sole purpose of this non profit corporation is to preserve, protect and defend the neighborhood bounded by west of LeJeune Road, South of Biltmore Way, North of University Drive, and in the general area of Segovia Ave.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE X: AMENDMENTS


The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
