Name

The name of the Corporation shall be: Heart of Florida Community Development Corporation.

ARTICLE

Principal Office

The principal place of business and mailing address of this corporation shall be: 1713 Silver Springs Blvd., Suite 2-C, Ocala, Florida 34470.

ARTICLE III

Purpose

The purpose for which Heart of Florida Community Development Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.


ARTICLE VIII
