ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JAGUAR LAKES HOMEOWNERS ASSOCIATION, INC.

ARTICLE I

The name of the corporation is Jaguar Lakes Homeowners Association, Inc. (the "Corporation").

ARTICLE II

Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following new Article I:

Article VI of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following new Article VI:

"6.1 Officers: The affairs of the Association shall be administered by a President, Vice President, Secretary, Treasurer and such other officers as may from time to time be created by the Board of Directors as permitted by the Bylaws. Officers shall be elected by the Board of Directors and shall serve at the pleasure of the Board. Offices may be combined as provided in the Bylaws.
