

For

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, (Not for profit) adopts the following Articles of Incorporation of such corporation:

ARTICLE I: Name

The name of the corporation shall be The Children's Academy at Covenant, Inc.

ARTICLE II: Principal Office

The principal place of business of the corporation shall be 9153 Roan Lane, Palm Beach Gardens, FL 33403.

ARTICLE III: Purpose

The Children's Academy at Covenant, Inc., is organized for the purpose of providing quality care, education, and training of children in an atmosphere of Christian excellence.

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any

future tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV: Manner of Election

The qualifications for members and the manner of their admission will be provided for in the bylaws, which will be adopted at the organizational meeting.

ARTICLE V: Initial Directors/Officers




