ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

BLEU CLAIRE CONDOMINIUM ASSOCIATION ON LONGBOAT KE (Document Filing Number N05000012664)

There are no members or members entitle to vote on this Amendments | The Amendments below were adopted by the Board of Directors of July 12, 2006. The Effective Date of this Amendment shall be the date of adoption.

Pursuant to the provisions of section 617.1006, Florida Statues, this Florida Not For Profit Corporation adopts the following amendments to this Articles of Incorporation:

Article III entitled "Powers" shall be amended to add a section "B" entitled "Additional Powers". Article III (B) shall read:

- B. Additional Powers. The Association shall further have the power to do the following:
 - (i) Own and convey property;
 - (ii) Operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas;
 - (iii) Establish rules and regulations;
 - (iv) Assess members and enforce assessments;
 - (v) Sue and be sued;
 - (vi) Contract for services to provide for operation and maintenance of the surface water management system facilities if the association contemplates employing a maintenance company; and
 - (vii) Take any other action necessary for the purposes for which the Association is organized.

Article VII entitled "Existence" shall be amended in the following manner:

This corporation shall exist perpetually unless dissolved according to law. In the event the Association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.
