## **ARTICLES OF INCORPORATION**

### **SPECIAL PROVISIONS**

- a. The Adventure Kids Corporation will continue to operate with the understanding of raising monies in order to contribute to other charitable not for profit organizations. These organizations will be of charitable, educational as well as religious organizations looking out for the wellbeing of others.
- b. Not at any time will net earnings of the organization be distributed to any member, trustee or board member as a salary or wage. This though will empower the organization to pay reasonable compensation for services rendered and to distributions in the furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, intervene in (including the publishing or distribution of statements) any political campaign on provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under the section 501 (c) (3) federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- c. If and when the Adventure Kids program is forced to shutdown all assets shall be distributed for one or more exempt purposes within the meaning of section 501 (3) © of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a local government or state, for public purpose. Any such Assets not disposed of by the court of Common Pleas of the county of which the principal office of the organization is then located, exclusively for such purposes.
