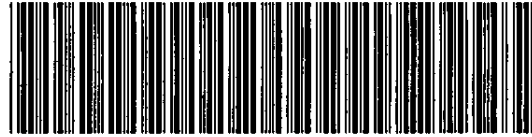

Article 2- Purpose

The Corporation is organized and shall operate exclusively for charitable, educational, religious and scientific purposes; including for such purposes, the making of distributions to organizations that qualify as exempt organizations under sections 501(c)(3), 2055(a) and 170(c) of the Internal Revenue Code of 1986, as amended (the "Code") (or any corresponding provisions of succeeding law), or provide scholarships and make grants directly to individuals for hardship, emergency assistance, and medical distress as long as they meet certain IRS criteria. In the case of scholarship awards, the grant is to be used for study at an educational institution that normally maintains a regular faculty and curriculum and normally has a regularly organized body of students in attendance at the place where the educational activities are carried on. For these purposes, grant recipients need not be limited to degree candidates, nor must the grant be limited to tuition, fees, and course-required books, supplies and equipment. A recipient may use grant funds for room, board, travel, research, clerical help or equipment, that are incidental to the purposes of the scholarship or fellowship grant. The Corporation may engage in only such activities permitted under the laws of the State of Florida and the United States of America as shall constitute activities in furtherance of such exempt charitable, educational, religious and scientific purposes. In furtherance of such purposes, it may promote, establish, conduct and maintain activities on its own behalf and it may contribute to or otherwise assist other corporations, organizations and institutions carrying on such activities.


