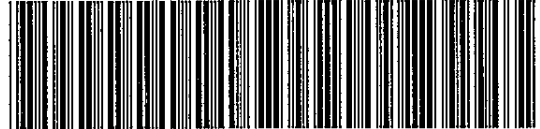

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

The National Engineering & Science Foundation (NESF) Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Tamarac, FL 33321**

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The National Engineering & Science Foundation's (NESF) purpose is to financially support science, engineering, and technical career programs in education, which includes but is not limited to specifics such as transportation, scholarships, promotional materials, student outreach programs, operating materials, registration & entrance fees, teacher professional development and student academic enrichment.

The foundation may also be used to secure and/or improve a structure through purchase, rent or lease in order to serve as either a central office for the personnel or other NESF purposes. Capital equipment and promotional resources may also be purchased, rented, leased, replaced and/or improved for NESF purposes. Resources from the foundation will be used to fund scholarship opportunities for students, teachers and prospective teachers. Eligibility for scholarships will be determined based upon the individual scholarship, but will include need-based, academic record, career choice, college choice, educational field, application documents, and written submission of request/essay, and other requirements as determined by the NESF Foundation board.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Board members will be elected annually by the members.

The structure of The National Engineering & Science Foundation's (NESF) Foundation will include a board of at least 3 members made up of professional educators, community members, and experienced fundraisers.

Any change in the make-up and membership of the board must be agreed upon by a majority vote of the board, with at least two-thirds of the board members present and voting. Board members will NOT be compensated upon the termination or retirement of their positions within the NESF Foundation.

ARTICLE VIII COMPENSATION STRUCTURE

Charlotte Speakman will be paid a specific percent depending on event, planning and the board's discretion. Jennifer Hager & David Platt will not be compensated as Directors.

Breakdown of Compensation for Event Coordinators

10% on donations found, generated or created by the specific coordinator.
15% on successful grants found, generated or created by the specific coordinator.
10-15% on the net proceeds from any specific fundraising events, as determined by a majority of the board (See Article X) on an event-to-event basis.

In order to be compensated for an event, the coordinators must guarantee, in writing, that the net proceeds to the NESF Foundation will at be at least 50% of the gross receipts or funds generated for that event

In the event of the dissolution of the NESF, all corporate funds held at that time will be dispersed to similar and/or related organizations and NOT to be applied to any current or former NESF board members and/or employees.

ARTICLE IX CORPORATE VOTING PROCEDURES

Approval will be determined by a majority vote of the board, with at least two-thirds of the board members present and voting. In lieu of a physical meeting, an electronic vote will be taken via e-mail, with board members having 72 hours after the initial vote is called to reply and respond with their ballot.

ARTICLE X EFFECTIVE DATE

January 1st, 2006


