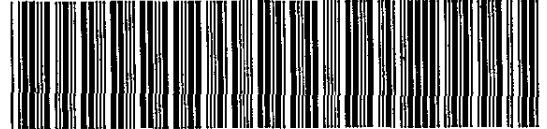

These Articles of Amendment were adopted by the board of directors of said this Corporation at a regular meeting with a quorum being present which was held on November 18th, 2005. This board meeting met the requirements of both the Articles of Incorporation and the bylaws. AMENDMENT: The Article of Incorporation of the Build Affordable America, Inc. are hereby amended as follows: 1. Article 0001 of the Articles of Incorporation is hereby amended to add the following paragraph: Whereas, the Board of Directors desires to qualify this Corporation as a "Community Based Development Organization" under the federal regulations found at 24 CFR570.204, and Whereas, to do this bylaws of this Corporation must be amended for the reasons the following Resolutions were adopted: Resolved that Article 0001 of the Bylaws of this Corporation are amended to add the following new paragraph: The geographic area of operation of this Corporation shall be Neighborhood Revitalization Strategy Area of Florida the State (as designated by Office of Community and Economic Development). It was further RESOLVED that Article 0001 of the Bylaws of this Corporation are amended to add the following new paragraph: Regardless of any other provisions of these Bylaws, at all times at least 51 percent of this Corporation's board of directors must be composed of persons in one or more of the following categories: low and moderate-income residents of its geographic area of operation; owners or senior officers of private establishments and other institutions located in and serving its geographic area of operation; or representatives of low and moderate income neighborhood organizations located in its geographic area of operation.
