**ARTICLE I NAME**

The name of the corporation shall be: **Sonrise Publishing Inc.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
**10537 Valentine Road South, Tallahassee, FL 32317**

**ARTICLE III PURPOSE**

Notwithstanding any other provision of these Articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the means of 501 c(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

**ARTICLE IV MANNER OF ELECTION**

The Board of Directors named in Article V shall hold office until the first annual meeting of the Board of Directors to be held as prescribed in the Bylaws, but in no event later than twelve (12) months from the date of incorporation, at which time an election of directors shall be held. The manner in which election of directors are elected shall be as provided in the Bylaws of the corporation.

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against employees, participants, and others on the basis of race, color, or national or ethnic origin.
