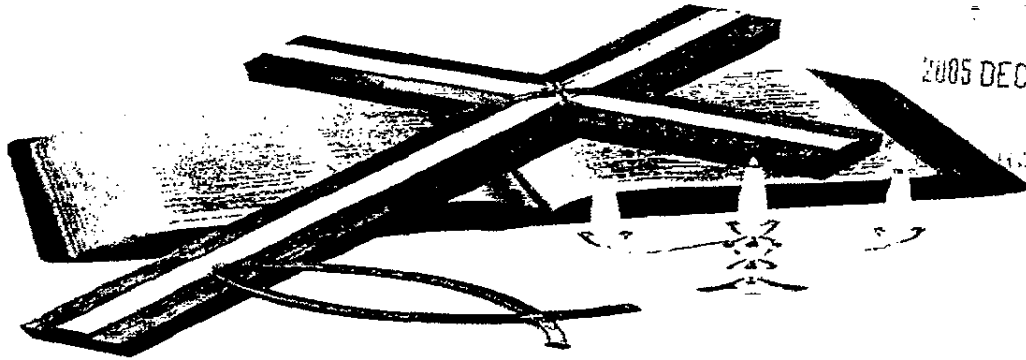

ARTICLES OF INCORORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

THE ARTICLES OF INCORPORATION OF BORN AGAIN CHURCH OF GOD, INC.

PREAMBLE

Whereas, we, a body of believers in Jesus Christ, collectively joined together for the sole purpose of the gospel of our Lord as recorded in the Holy Scripture, deem it wise that we have certain laws to serve as a criterion to work by; thereby it is resolved: that beginning its legal adoption thereof we shall be governed by the following Articles of Incorporation.

ARTICLE I-NAME

The name of this organization, a non-profit religious corporation organized under the laws of the State of Florida, is *Born Again Church of God, Inc.*

ARTICLE II-PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: *674 West Comstock Avenue, Winter Park, Florida 32789*

ARTICLE III-PURPOSE

The purpose for which the corporation is organized is:

1. To build, in Christ, a church of love where believers by working together for the unity, edification, discipline, and encouragement of believers and that they grow into the image of Christ.
2. To minister to people of all faith.
3. To provide outreach ministries to those in need.

ARTICLE IV-MANNER OF ELECTION

1. **President/Pastors:** Ultimate authority in the church shall reside with the President/Pastor under the teaching of Jesus Christ, the Head of the Church.
2. **Secretary:** Appointed by the President/Pastor, must be an active member of the church in good standing, willing to serve and follows the rules of the church according to the Word of God, to maintain records of all funds, to keep the minutes for all meetings and do all the record keeping for the church.
3. **Treasurer:** Appointed by the President/Pastor, must be an active member of the church in good standing, willing to serve and follows the rules of the church according to the Word of God, must be willing to collect tithes and offerings. Person collecting tithes and offerings shall keep a record of all monies received and deposit all funds into church accounts in financial institutions used by the church. The treasurer shall provide monthly and annually receipts for members who make offerings to the church before the end of the fiscal year.

1. The fiscal year shall begin on January 1st and end the following December 31st.
2. In the event of decease of the President/Pastor, *Earlene Blue*, shall become head of the church, second only to Jesus Christ.
