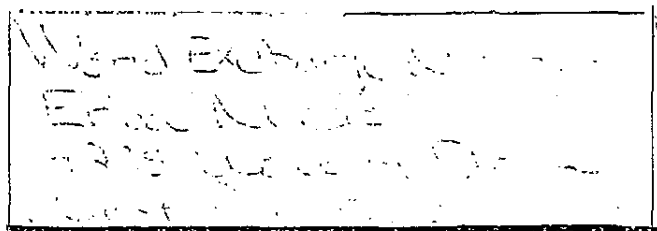



**ONE:** The name and address of this principal Corporation is World Exchange Ministries, 4235 Waverly Drive, West Palm Beach, Florida 33407, in Palm Beach County. The Corporation is organized pursuant to the Florida Corporation Code.

**TWO:** This Corporation is a non-profit religious benefit Corporation organized under the Nonprofit Public Benefit Corporation Law for Religious purposes. To establish structured support services for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation's creed/By-Laws as a Pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but shall not be limited to: Homelessness, Health Care, Computer Technology, Child Care, At Risk Youth, Tutorial, Land Acquisition, Housing, Job Training, Mentorship, Counseling, Aids Prevention, Employment and other programs to aid those in need.

**THREE:** The duration of this Corporation shall be perpetual, no stock and have no members.
