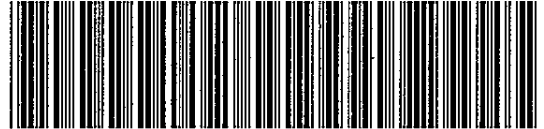

**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of this corporation shall be DEBBIE WARD MINISTRIES, INC.

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

DeLand, Fl. 32724

**ARTICLE III**

**PURPOSE**

The general nature of business to be transacted by this corporation is faith supported missionary work with the Wounaan Indians, on the Chagres River, from Gamboa to San Antonio, all in the Country of Panama, and transacting any and all business for which non-profit corporations may be incorporated under the laws of the State of Florida, as may be amended from time to time, except that said corporation is organized exclusively for charitable, religious, educational and scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as may be amended from time to time, or the corresponding provisions of any future United States Laws.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office, Notwithstanding any other provisions of these articles, the corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**ARTICLE IV**  
**MANNER OF ELECTION**

The manner in which the directors are elected shall be pursuant to the bylaws of the corporation.
