ARTICLES OF INCORPORATION

The undersigned, all of lawful age and citizens of the United Sates of America, hereby assign ourselves to being a corporation not for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation of the corporation shall be FAITH IN CHRIST ANGLICAN CHRUCH, INC., a corporation not for profit.

ARTICLE II

Purpose

The purpose of this corporation shall be to operate a local church for corporate worship and to study and learn the Word of God as taught in the Authorative Holy Bible.

This corporation is organized exclusively for religious, charitable and educational purposes consistent with §501(c)(3) of the Internal Revenue Code.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The affairs of the corporation shall be managed by the officers of the corporation as set forth in ARTICLE V below. All officers shall be elected annually and the election shall occur at the annual business meeting of the Board of Directors of the corporation.

In the event of the dissolution of this corporation, the residual assets of the organization shall be turned over to such other organization or organizations organized and operated exclusively for religious purposes and specifically of the Anglican faith, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall qualify as an exempt corporation or organization under §510(c)(3) and §170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, of the federal, state or local government for exclusive public purposes.
