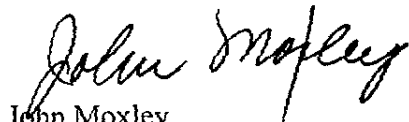

FAITH IN CHRIST ANGLICAN CHURCH, INC.

The undersigned, all of lawful age and citizens of the United States of America, hereby assign ourselves to being a corporation not for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation of the corporation shall be FAITH IN CHRIST ANGLICAN CHURCH, INC., a corporation not for profit.

ARTICLE II

Purpose

The purpose of this corporation shall be to operate a local church for corporate worship and to study and learn the Word of God as taught in the Authoritative Holy Bible.

This corporation is organized exclusively for religious, charitable and educational purposes consistent with §501(c)(3) of the Internal Revenue Code.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The affairs of the corporation shall be managed by the officers of the corporation as set forth in ARTICLE V below. All officers shall be elected annually and the election shall occur at the annual business meeting of the Board of Directors of the corporation.

ARTICLE V

The names and addresses of the officers who shall serve until the first election or until their successors are appointed or elected are:

ARTICLE VI

The corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time by By-Laws adopted by the Board of Directors but shall never be less than three (3). The number of directors shall be elected pursuant to the By-Laws adopted by the corporation. The names of the directors who are to serve until the first election or until successors are elected or appointed are:

ARTICLE VII

The initial principal street address of the office of the corporation shall be 9317 U. S. Highway 90 West, Lake City, FL 32055.

ARTICLE VIII

By-Laws of the corporation may be made, altered or rescinded by the Board of Directors of the corporation at any annual business meeting or at any special business meeting called for that purpose by a two-thirds (2/3) majority vote of the Board of Directors.

ARTICLE IX

Amendments to the Articles of Incorporation shall be made at any annual business meeting of the corporation, or upon any special business meeting called for that purpose. Such amendment shall be proposed by the Board of Directors and must be adopted by a two-thirds (2/3) majority vote of the membership of the corporation.

ARTICLE X

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Revenue code as amended from time to time.

In the event of the dissolution of this corporation, the residual assets of the organization shall be turned over to such other organization or organizations organized and operated exclusively for religious purposes and specifically of the Anglican faith, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall qualify as an exempt corporation or organization under §510(c)(3) and §170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, of the federal, state or local government for exclusive public purposes.

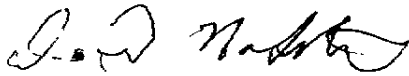
