ARTICLES OF INCORPORATION

of

OS PILED

COALITION FOR ANIMAL WELFARE/WEST CENTRAL FLORIDA, INC. A Florida Not-For-Profit Corporation

ARTICLE I Name

The name of the corporation shall be COALITION FOR ANIMAL WELFARE/WEST CENTRAL FLORIDA, INC.

ARTICLE II Not-for Profit Corporation

The corporation shall be not-for-profit in compliance with Chapter 617 of the Florida Statutes.

ARTICLE III Principal Office

The principal place of business and mailing address of this corporation shall be 12177 Timberlane, Brooksville, FL 34601.

ARTICLE IV

The purpose for which the corporation is organized is to promote animal welfare as follows:

- a. By encouraging spaying and neutering of animals,
- b. By educating both adults and children on animal welfare,
- c. By identifying and preventing animal cruelty,
- d. By devising a plan for disaster relief and shelter for animals during natural disasters,
- e. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE V Designation as 501(c)(3) Organization

The corporation is organized and shall be operated exclusively for scientific, educational, charitable, and religious purposes; and it is authorized to accept, hold, administer, invest, and disburse for scientific, educational, charitable, and religious purposes, such funds as may from time to time be given to it by any person, persons, corporations or government entities, to receive gifts and make financial and other types of contribution and assistance to scientific, educational, charitable, and religious organizations, and governmental entitles, including, but not limited to, rendering support, aid, advice and services to scientific, educational, charitable, and religious organizations and governmental entities.

All of the assets and earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto; and no part of the net earnings shall inure to the benefit of any individual and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

Nothwithstanding any other provision of these articles, the corporation will not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

In the event of dissolution, all of the remaining assets of the corporation shall be distributed only for scientific, educational, charitable and religious purposes to organizations which have been ruled exempt by the Internal Revenue Code under Section 501(c)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws.

In attempting to fulfill the general nature of the objects of this corporation, this corporation shall and must strictly adhere to the following provisions:

- A. The corporation shall not engage in any act of self-dealing as mentioned in Section 4941(d) of the Internal Revenue Code of 1954, or any corresponding provision of any subsequent federal tax laws.
- B. The corporation shall not make any investments which jeopardize its charitable purpose, and, accordingly, its investments shall be made in such a manner as not to subject the corporation to tax under Section 4944 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.
- C. The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE VI Manner of Election

The manner in which the directors are elected or appointed will be by a majority vote of the members of the corporation on an annual basis or as otherwise determined.

ARTICLE VII Initial Registered Agent and Street Address
