

ARTICLE I NAME:

The name of the Corporation shall be MINISTERIO MISIONERO JESUCRISTO ES EL CAMINO INCORPORATED, a Corporation of religious nature non-profit organization.

ARTICLE IV MANNER OF ELECTION:

The Manner in which members and directors are elected and appointed is as follows:

- 2. The General Assembly- is composed of members registered in the corporation and will have functions as appointed by the Board of Directors.
