Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approval must be <u>by</u> either:
- a. by not less than 65% of the entire membership of the board of directors and by not less than 65% 2/3 of the votes of the entire membership of the Association, present at a meeting in which a quorum is established in person or by proxy.; or

b. by not less than 70% of the votes of the entire membership of the Association.
