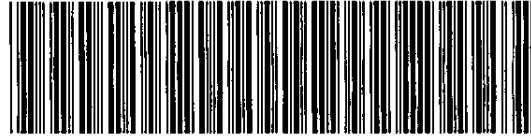

ARTICLES OF INCORPORATION
OF
PEDRO BAPTIST CHURCH, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, under the following proposed charter:

ARTICLE I – NAME

The name of this corporation shall be:

StartingPoint Church, Inc.

And is to be located at 1990 SE Hwy 42, Summerfield, Florida 34491.

ARTICLE II – PURPOSE

The purpose of this corporation is for the propagation of the Holy Scriptures, the Gospel of Jesus Christ and to come govern this corporation by our religious laws.

ARTICLE III – MEMBERSHIP

Membership in this corporation shall consist of all active members of StartingPoint Church, Inc. Addition or deletion from the rolls of the Church shall automatically add or delete such persons from membership of the corporation.

ARTICLE IV – TERM

The corporation shall have perpetual existence.

ARTICLE V – SUBSCRIBERS

The names and residences of the subscribers of this corporation are as follows:

ARTICLE VI – OFFICERS

The affairs of this corporation are to be managed by not less than two nor more than five members who shall comprise the Board of Directors, and who shall be appointed by the Pastoral Staff as provided in the by-laws. From the Board of Directors there shall be an appointed President and Vice-President, an appointed Secretary who shall be the Church Clerk, and an appointed Treasurer who shall serve as the Church Treasurer. Such officers shall serve for terms of two years and may be asked to serve additional consecutive terms.

ARTICLE VII – FIRST OFFICERS AND DIRECTORS

The names of the officers who are to manage all the affairs under the leadership of the Pastoral Staff are as follows:

The number of persons constituting the first Board of Directors shall be two members, whose names and addresses are as follows:

ARTICLE VIII – BY-LAWS

The By-Laws of this corporation are Theocratic and are under the leadership of the Senior Pastor. They may be amended under the advisement of the Pastoral Staff after being presented to the Board of Directors.

ARTICLE IX – AMENDMENTS

Amendments to this Charter or Articles of Incorporation may be proposed by the Board of Directors and the Pastoral Staff.

ARTICLE X – POWERS

This corporation may hold real estate of unlimited value. The corporation is granted all those powers allowed to it under Section 617.021, Florida Statutes 1965.

ARTICLE XI – GOVERNMENT

The government of StartingPoint Church, Inc is a Theocratic Government led by the Pastoral Staff and is subject to the control of no other ecclesiastical body. It does, however, recommend and sustain the mutual counsel and co-operation which are among the churches of the Southern Baptist Convention.

ARTICLE XII – REGISTERED AGENT

In pursuance of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

First: That StartingPoint Church, Inc. desiring to organize under the Laws of the State of Florida with its principal office, as indicated in these Articles of Incorporation, in the community of Summerfield, County of Marion, State of Florida, has Cynthia Mesa, located at 1990 SE Hwy 42, Summerfield, Florida 34491, as its agent to accept service of process within this state.

Acknowledgment: Having been named to accept service of process for the above state corporation, at the place designated in this certificate. I hereby

accept to act in this capacity, and agree to comply with the provisions of said Act relative to keeping open said office.
