*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST:** Amendment(s) adopted:

Amendments 17, 18 and 19 to be added as follows:

17. The present composition of the Board of Directors shall not be amended without a two-third majority of the dues-paying members of this parish, as per the list of present members kept by the current Vicar and President and or the secretary and the approval of the two third plus one majority of the current board of directors.
18. H.G. Mathews Mar Barnabas Metropolitan or any other official of the American diocese will have no administrative or property rights over St. Thomas(Indian)Orthodox Church of South Florida, Inc. until this entity's financial liability is fully absorbed by the diocese, fully incorporated to the diocesan incorporation by representation, with rights and duties clearly defined and approved and documented by the board, and approved by the two-thirds majority of the dues-paying members of the parish.
19. Any amendments or articles filed on behalf of the incorporation shall be signed by the current president, secretary or treasurer.

**SECOND:** The date of adoption of the amendments was: **May 26, 2002**
