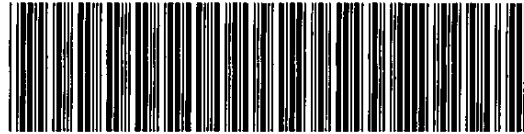

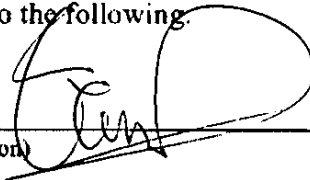

Article 20. Corporate property use/ stewardship

The Vicar of St. Thomas Indian Orthodox Church(parish) may be elected to the board only after he meets all membership

criteria (dues, capital funds, etc.) set forth by the articles of incorporation. Parish managing committee members may be elected

to the board. Parish managing committee membership is not a criteria to become the board member.

Appointment/election to the managing committee alone will not make one a board member and

removal from the managing committee alone will not constitute for the removal from the board.

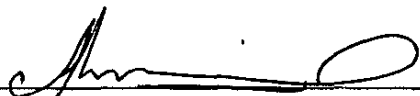
