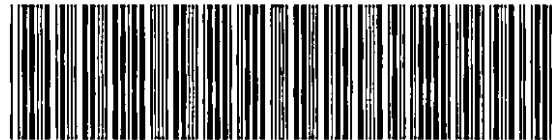

Cypress Meadows Community Church is organized exclusively for, and will be operated exclusively for, religious and charitable purposes. No part of the organization's net earnings will inure to the benefit of private shareholders or individuals. The organization won't attempt to influence legislation or participate to any extent in a political campaign for or against any candidate for public office. The organization shall own and maintain suitable real estate and buildings for its stated purpose, and to do all things necessary incident thereto. In the event of dissolution of the organization, and after settlement of any and all outstanding debts, the remaining assets will be split equally between the Southeastern District of the Christian and Missionary Alliance, Springs of Hope Kenya in Nakuru, Kenya, and Shiloh Church in St. Louis du Nord, Haiti.
