We, the President and the Assistant Secretary of Baptist Manor, Inc., a not for profit corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

- (1) The name of the Corporation is. The Baptist Manor, Inc.
- (2) The following amendment has been adopted in accordance with the requirements set forth in Chapter 617 of the Florida Statutes:

Article IV of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article IV:

ARTICLE IV

The corporation shall have a sole member, namely, Baptist Health Care Corporation, a Florida not for profit corporation as described in section 501(c)(3) of the Internal Revenue Code of 1986. The sole member shall have such rights and powers provided voting members from time to time by the Florida Not For Profit Corporation Act and such duties and responsibilities as are provided in the bylaws of the corporation.

- (3) The foregoing amendment was adopted by a vote of the Corporation's sole member, Baptist Health Affiliates, Inc., on January 18, 2001, which vote was sufficient for the amendment's approval.
