AMENDMENT TO THE ARTICLES OF INCORPORATION OF JAN McART'S AMERICAN FESTIVAL SERIES, INC.

The Articles of Incorporation of JAN McART'S AMERICAN FESTIVAL SERIES, INC., a Florida not-for-profit corporation ("Corporation") are amended to read as follows:

ARTICLE ONE

The name of the Corporation shall be:
