

We, the undersigned incorporators, adopt the following articles of amendment to the Articles of Incorporation in accordance with the laws of the State of Florida.

The following article has been amended to read:

ARTICLE II

NATURE AND PURPOSE

(a) The purpose of this Corporation shall be to engage in the business of providing quality education.

(b) The purposes for which the Corporation is organized are exclusively educational, charitable, scientific, and literary within the meaning of section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.
