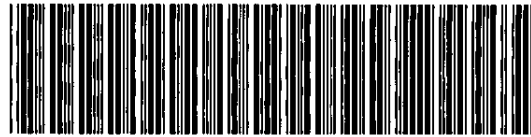

ADD ARTICLE- III-G MEMBERSHIP PROVISION

Membership in Cinnamon Street Baptist Church is a privilege and not a right and carries with it specific responsibilities and moral obligations, the following provision.

The membership of any individual member shall automatically terminate without notice if the member states that he or she is actively involved in any conduct described in **ARTICLE XV-A-a**.

ADD ARTICLE III-G-1 RESOLUTION

The governing board of Cinnamon Street Baptist Church resolves to protect the Bible-based moral values of this ministry. The following policies represent the ministry's commitment to preserve Scriptural morals in the face of outside societal influences seeking to degrade the Biblical family, pervert the moral values of our nation, and intimidate God's people from speaking God's truth in love.

ADD ARTICLE III-G-2 CHURCH ATTENDANCE/SERVICES

Attendance in the general worship services of this church shall be open to the general public subject to the standards and expectations contained in this resolution and other applicable ministry policies.

ADD ARTICLE III-G-3 Behavior Standards

In all services and programs of this ministry, reasonable standards of decorum and order shall be maintained at all times. As such, no one shall, by appearance or behavior, be permitted to draw attention to themselves in contravention to the ministry's purposes. Any individual who, in the sole discretion of the pastor or ministry leadership, is found to be in violation of this policy shall be removed from the ministry premises immediately.

Add Article VIII- A to Resignation of OFFICERS

- A.** Any licensed or ordained minister who has been ordained or licensed by Cinnamon Street Baptist Church who has lapsed into moral or spiritual sin that brings shame upon Cinnamon Street Baptist Church or upon God, or upon Christ Jesus and/or the Holy Spirit will be required to return their license and/or their ordination paper over to CSBC. They will no longer be an ordained or licensed minister of Cinnamon Street Baptist Church. A certified letter with return receipt will be sent to that person notifying them that their license or ordination has been revoked.

CHANGE ARTICLE XV-A-a HUMAN SEXUALITY TO READ

Cinnamon Street Baptist Church believes that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man (male) and a woman (female). We believe that any form of homosexuality, lesbianism, bisexuality, bestiality, incest, fornication, adultery, and pornography are sinful perversions of God's gift of sex. We believe that God disapproves of and forbids any attempt to alter one's gender by surgery or appearance. (Gen. 2:24; Gen. 19:5, 13; Gen. 26:8-9; Lev. 18:1-30; Rom. 1: 26-29; 1 Cor. 5:1; 6:9; 1 Thess. 4:1-8; Heb. 13:4). All of the above scripture references are from the King James (1611) Version of the Bible.

CHANGE ARTICLE XV-A-b HUMAN SEXUALITY TO READ

Cinnamon Street Baptist Church believes that the only Scriptural marriage is the joining of one man and one woman as God created them. (Gen. 2:24; Rom. 7:2; 1 Cor. 7:10; Eph. 5:22-23)

REMOVE 1-D-10 FROM ARTICLE XVI WEDDING RULES

Anyone who has engaged in pre-marital sex will have a small discrete ceremony after the Wednesday night prayer service or have a ceremony in the fellowship hall with only close friends and family attending.

ADD NEW 1-D-10 TO ARTICLE XVI WEDDING RULES

There will be no dancing, drinking, or smoking during the wedding or reception on church grounds.
