

## **ARTICLES OF AMENDMENT** TO ARTICLES OF INCORPORATION FOR



Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment adopted:

Article IX, Section J. of the Articles of Incorporation is amended to read as follows:
