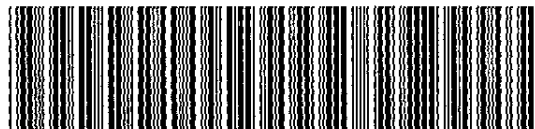

## Articles of Incorporation

### Article I

The name of the corporation shall be Dads 4Life, Inc.

### Article II

The principle place of business for Dads 4Life is 10353 Old Plank Road, Jacksonville, Florida 32220

### Article III

The Purpose of this organization is organized as a corporation not for profit, exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including but not limited to the following: Dads 4Life will provide Fathers of all ages, races, religion or cultures the support, education and information to enhance their lives and change the future of our Country by teaching Fathers to stay involved in the children's lives. We will help Fathers understand their role in society, responsibilities, and ownership of being a Father. We will establish support programs and continued training on various topics in life such as finances, leaving a legacy to your children, and continuing education. Our program will reinforce the strong commitment to community, family and church involvement. The corporate powers of the corporation are as provided in Section 617.0302, Florida Statutes except to the extent such powers are limited by the following provisions of this Article.

- (a) No part of the assets or net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article IV hereof.
- (b) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except to the extent permitted pursuant to an election made under Section 501 (h) of the Internal revenue Code), and the corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
- (c) Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I ) by a corporation qualifying for exemption from federal income tax as an organization described in Section 501 (c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or the corresponding section of any future federal tax code.
- (d) Upon the dissolution of the Corporation, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 ( c ) (3) of the Code, or shall be disturbed to the federal government, or to a state or local government, for a public purpose. Any such assets nor so disposed of shall be disposed by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes

or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

#### Article IV

The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. The Board of Directors will initially consist of three members. The Board of Directors may propose a vote to add additional Directors. Director's elections will be held annually. The terms of the initial Directors or subsequently elected Directors will end at the next Board meeting following their election, at which time either new Directors will be elected or current Directors will be reelected.
