We, the undersigned, have associated ourselves together and do hereby, associate ourselves together, for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, pursuant to the following Articles of Incorporation.

ARTICLE L NAME

The name of the Corporation shall be: BOBBY MADURO FOUNDATION, CORP.,

ARTICLE IL DURATION

This Corporation shall have perpenual existence.

ARTICLE III: PURPOSE

The general nature and purpose for which this Corporation is organized are:

- a. To promote the ideals of family, faith, and sports exemplified by Bobby Maduro.
- b. To provide financial support for low income inner city youths to play, learn and compete in the sport of baseball.
- c. To provide instructors, equipment, and financial support to low income youths to compete in the sport of baseball.

- f. Support the foundation of other athletes, with synergistic goals and values.

ARTICLE IV

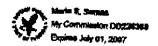
