

# **Articles of Incorporation**

### Article I - Name

IALLAHASSEE FLORIDA

The name of this corporation shall be: Bridge of Love Ministries International, Inc.

## Article II - Principal Office

## Article III - Duration

This not for profit corporation shall have perpetual existence commencing from the original filing date of Bridge of Love Ministries International, Inc. of the Articles of Incorporation with the Florida Department of State.

### Article IV - Corporate Purpose

The purpose of this corporation shall be to:

1. Organize churches, outreaches, and educational institutes/schools according to and consistent with its doctrine.

# Article V - Corporate Powers
