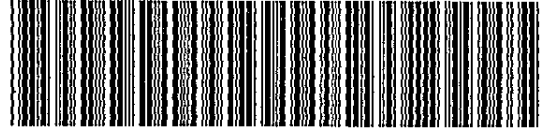

Articles of Incorporation

Article I – Name

ALLAHASSEE FLORIDA

The name of this corporation shall be:
Bridge of Love Ministries International, Inc.

Article II – Principal Office

The principal business address of this corporation is:
5809 Windhover Drive, Orlando, FL 32819.

Article III - Duration

This not for profit corporation shall have perpetual existence commencing from the original filing date of Bridge of Love Ministries International, Inc. of the Articles of Incorporation with the Florida Department of State.

Article IV – Corporate Purpose

The purpose of this corporation shall be to:

1. Organize churches, outreaches, and educational institutes/schools according to and consistent with its doctrine.

Article V – Corporate Powers

Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Article VI – No Capital Stock

This corporation is organized on a non-stock basis. The corporation shall not issue stock. No dividends shall be paid, and no part of the income of the corporation shall be distributed to its members, directors or officers.

Article VII – Dissolution

Upon the dissolution of this corporation, the Board of Directors shall, after paying and/or make provisions for the payment of all the liabilities of the corporation, dispose of all assets of the corporation exclusively for the purpose of the corporation in charitable, educational, religious, or scientific purposes, and shall at the time qualify as an exempt corporation or organization under and within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or a corresponding section of any future federal tax code, or shall be distribute to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such corporation or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

Article VIII – Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 5809 Windhover Drive, Orlando, FL 32819, and the name of the initial registered agent of this corporation at that address is Carmen L. Crespo.

Article X – Board of Directors

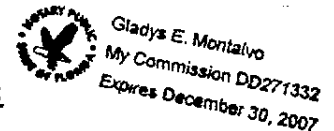
