WHEREAS, pursuant to Section 4.15 of the Bylaws of Marina Bay of Fort Myers Homeowners Association, Inc. (the "Bylaws"), prior to the Turnover Date and except as to assessments, any action required or permitted to be taken at a meeting of the Board may be taken without a meeting if a consent in writing, specifically setting forth the action to be taken, is signed by all of directors of the Board entitled to vote with respect to the subject matter thereof, and such consent shall have the same force and effect as a unanimous vote of the Board; and

WHEREAS, the First Conveyance has occurred as of the date of this Certificate of Filing, and the Turnover Date has not occurred as of the date of this Certificate of Filing; therefore, the Association's members are not entitled to vote on a proposed amendment to the Articles; and

WHEREAS, in accordance with Article XIII, Section B of the Articles, on September 19, 2020, the Board approved the Second Amendment to the Articles, as further set forth herein, by unanimous written consent in accordance with Section 4.15 of the Bylaws.

SECOND AMENDMENT TO THE ARTICLES OF INCORPORATION OF MARINA BAY OF FORT MYERS HOMEOWNERS ASSOCIATION, INC.

Article X, Section I of the Articles is hereby amended to provide the following:

I. At each Annual Members' Meeting held subsequent to Declarant's Resignation Event, all of the Directors shall be elected by the Members (a "Member Elected Board"); provided, however, that no such election of a Member Elected Board shall occur at the Annual Members' Meeting occurring in the same calendar year as an election of an Initial Elected Board notwithstanding anything to the contrary set out in the Bylaws or these Articles of Incorporation. At the first Annual Members' Meeting hold after the Initial Election Meeting of a Member Elected Board, a "staggered" term of office of the Board shall be created as follows:
