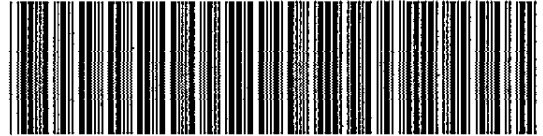

# ARTICLES OF INCORPORATION FOR A NOT FOR PROFIT CORPORATION

## KIWANIS CLUB OF GREATER SUNRISE IN BROWARD, FLORIDA, INC.

We the undersigned, for the purpose of organizing a corporation, not for profit, under the laws of the State of Florida, do make, subscribe, acknowledge and tender to the office of the Secretary of State of Florida, for its approval, the following Articles of Incorporation.

### ARTICLE 1

#### NAME

The name of this corporation shall be **KIWANIS CLUB OF GREATER SUNRISE IN BROWARD, FLORIDA, INC.**

### ARTICLE 11

#### PRINCIPAL OFFICE

The Principal place of business and mailing address of this corporation is: **7481 WEST OAKLAND PARK BLVD., SUITE 205, FT. LAUDERDALE, FLORIDA 33319**

### ARTICLE III

#### PURPOSE

The purposes for which this corporation is organized are as follows:

1. To give primacy to the human and spiritual rather than to the material values of life.
2. To encourage the daily living of the Golden Rule in all human relationships.
3. To promote the adoption and the application of higher social, business, and professional standards.
4. To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
5. To provide, through Kiwanis clubs, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
6. To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and goodwill.
7. For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Greater Sunrise in Broward, Florida and its members.
8. To do such things as are incidental or conducive to the attainment of the above objects.

### ARTICLE IV

#### MEMBERSHIP

The members of the corporation shall be elected by the membership in accordance with the by-laws. Membership shall consist of four classes: active, privileged, senior and honorary. By-laws shall prescribe the rights and duties of each class membership.

## **ARTICLE VIII**

### **OFFICERS**

**The affairs of this corporation shall be managed by the following officers and directors: President, President Elect, Vice –President, Secretary, Treasurer, Immediate Past President and five Directors.**

**The election of officers and directors, except Secretary shall be held at the annual meeting. Voting shall be by ballot, and shall not be cumulative. Only active, privileged and senior members present and in good standing may vote. There shall be no voting by proxy. The Secretary shall be appointed within one week from the annual meeting by the officers and directors who comprise the Board of Directors of the succeeding year.**

## **ARTICLE IX**

**The Board of Directors shall consist of eleven persons, and shall be made up of those Directors and Officers set forth in the above Article 7. ## ARTICLE XII




## ARTICLE XIII
