The undersigned, acting as incorporator of a corporation under the Florida nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is Mastering Minds, Inc. 9702 Port Colony Way, Tampa, Florida 33615-4222

ARTICLE II

Duration

The period for which the Corporation is organized shall be perpetual.

ARTICLE III

Exempt Purposes

The Corporation is organized and shall operate as an exempt religious, charitable and educational organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future tax code as amended without profit to any officer or director and the Corporation.

ARTICLE IV

Specific Purposes

The Corporation is incorporated under the laws of the State of Florida specifically to assist State and Federal agencies and the residents of the Tampa Bay Area and its surrounding communities located in Hillsborough County to educationally, spiritually, and physically aid and support the underprivileged. Subject to the limitations set forth in Article III, the Corporation may also engage in all other activities which are permissible by law.

ARTICLE V

Membership

The Corporation shall not have any members.

ARTICLE VI

Directors

The number of directors constituting the initial board of directors is [three (3)]. The management of this corporation shall be vested in a Board of Directors. The numbers of directors and the method of selecting shall be fixed by the bylaws of this corporation, provided that the initial directors shall be three (3) no more than seven (7). Prohibitions

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of Corporation set forth in Articles III and IV hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE VIII

Dissolution

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all of the

assets of the Corporation to such organization or organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Code, as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX
