Articles of Incorporations of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation in compliance with Chapter 617, F.S., do herby certify:

ARTICLE I

NAME OF CORPORATION

The name of the corporation (church) shall be Greater Central Church of Orlando, Inc.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be in the City of Orlando, County of Orange, State of Florida. The street address and mailing address of the church shall be 1316 West 22nd Street, Orlando, FL 32805.

ARTICLE III PURPOSE
